

#### 1 Respective responsibilities of the body and the auditor

#### 2 External auditor report 2018/19

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with *Proper Practices* and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review. Please ensure that amendments are corrected in the prior year comparatives when completing next year's AGAR:

- Section 106 receipts have been incorrectly included as reconciling items between Boxes 7 and 8 in both the prior and current years, whereas they should have been shown as Box 3 income in the year of receipt and then held in Box 7 as earmarked reserves. Therefore, the figures in Boxes 1 and 7 should read £1,208,473 and £1,069,312 respectively for the prior year column, and, for the current year £1,069,312 and £875,179 respectively.
