




GENERAL NOTICE OF REGISTERABLE INTERESTS

I, LUNDA MENDEL a member of Hatfield Town Council, set out below under the appropriate headings my interests, which I am required to declare under the Localism Act 2011 and the Council's Code of Conduct and I have put "none" where I have no such interests under any heading.

<u>Disclosable Pecuniary Interests</u>
